# MARYLAND CHILD CARE SCHOLARSHIP PROGRAM

The Child Care Scholarship (CCS) Program provides financial assistance with child care costs to eligible families in Maryland.

To be eligible for the CCS Program, you must:

- Be a Maryland resident who is working/employed, in an approved training program or attending school. For families where both parents live within the same household, both parents must meet all eligibility requirements.
- Provide proof of identity for all household members (driver's license, birth certificate, or government-issued ID for adults, and a birth certificate for each child within your household).
- Provide proof of the last 4 weeks of all income for you, your spouse, another parent in the home with one child in common, parents of the minor parent, and adults or spouse with whom you share physical custody of the minor child(ren).
  - Most recent four (4) weeks of consecutive pay stubs (4 weekly, 2 bi-weekly, or 1 monthly) and/or proof of enrollment in school or training.
  - Supplemental Security Income (SSI) documentation for any household member (parent or child) who receives SSI (if applicable).
  - Proof of all other income (bonuses, commissions, etc.)
- Provide proof of home address (utility bill, lease, rental or mortgage agreement, driver's license if the address is the same as used for the Child Care Scholarship application).
- Provide proof of an approved activity schedule provided on the employer's or school's letterhead (i.e., work, school, or job training).
- Provide proof of Immunization for non-school-age children who are attending informal child care.
- Provide proof of U.S. Citizenship, legal alien status or proof of Head Start enrollment for all children needing a Child Care Scholarship. Parents **do not** have to be a U.S. Citizen.
